



Rating Action: Moody's assigns Aaa to Ottawa County, MI's GOLT bonds; outlook stable

New York, January 12, 2024 -- Moody's Investors Service has assigned a Aaa rating to Ottawa County, MI's Water Supply System Bonds (General Obligation Limited Tax) with a proposed par amount of about \$3.5 million. Moody's maintains the county's Aaa issuer rating and Aaa rating on outstanding general obligation limited tax (GOLT) debt. Following the sale, the county will have about \$154.6 million in GOLT debt outstanding. The outlook is stable.

RATINGS RATIONALE

The Aaa issuer rating reflects the county's stable local economy, modest fixed costs and proactive management that has supported the maintenance of strong operating reserves. The county's available fund balance ratio was nearly 70% in fiscal 2022 and its liquidity ratio was over 100%. The county was allocated a significant amount of federal stimulus, which has bolstered its financial position in recent years. Reserves will remain solid and comparable to peers nationally. The county's leverage ratio is low and maintained consistently under 200% of revenue. The county's leverage would rise to only roughly 250% of revenue if component unit debt and revenue is included.

The Aaa GOLT rating is the same as the issuer rating, based on the county's full faith and credit pledge.

RATING OUTLOOK

The stable outlook reflects our expectation that strong budgetary management and the county's large, diverse tax base will continue to support a stable financial profile.

LEGAL SECURITY

The county's outstanding GOLT bonds, including the current issuance, are backed by its full faith and credit pledge. The county's ability to raise funds to pay debt service is subject to applicable statutory and constitutional tax limitations.

USE OF PROCEEDS

Proceeds from the bonds will finance water supply system improvements.

PROFILE

Ottawa County encompasses roughly 565 square miles in southwestern Michigan (Aa1 stable). It is the eighth most populous county in the state, providing a full range of municipal services, including public safety, health and human services, and recreation, to over 296,000 residents.
