ITEM 1: VENDOR QUESTIONS RECEIVED AND ANSWERED:

- Q1. What is the number of inmates receiving medication-assisted treatment (MAT).ill the
- A1. Approximately 7 to 10 receive both continuation and induction treatment.
- Q2. Is there a medication room?
- A2. Yes, there is a secure medication room in the Jail's medical area.
- Q3. How many exam rooms are located at the Jail? How many at the Juvenile Detention Facility?
- A3. There are four (4) exam rooms at the Jail and one (1) at the Juvenile Detention Center that has an adjoining office and storage space.
- Q4. Where do inmates request medical passes?
- A4. An inmate would typically complete a medical pass request in the dayroom. They may also be completed in housing units / cells.

- Q5. What type of observation do cells have?
- A5. Cells have indirect observation.
- Q6. About how many bookings are done in a year?
- A6. In 2023, there were approximately 5,000 bookings and 1,795 intakes completed.
- Q7. Are there other cells that are used for medical care?
- A7. Yes, there are four (4) observation cells in the Jail medical area that are multi-use cells for clinics, infirmary level care or medical use.
- Q8. The current staffing plan provided on p. 8 of the RFP includes psychiatric staff (Psychiatric APRN/NP), but it does not include any mental health staff (i.e., Mental Health Professionals). However, p. 9 of the RFP shows statistics for mental health visits. Are those "mental health visits" being completed by the psychiatry staff?

- Q9. Is the incumbent medical provider staffing mental health positions (i.e., Mental Health Professionals) that are not shown in the matrix on RFP p. 8?

- Q10. Is a community mental health group/provider staffing Mental Health Professional (or counselor/therapist/social worker) positions at the facilities?
- A10. Answer not received in time for addendum, will issue response in Addendum No. 4.
- Q11. If mental health services are being provided by a community mental health group/provider, will that practice continue under the new contract?
- A11. Answer not received in time for addendum, will issue response in Addendum No. 4.
- Q12. Medication-Assisted Treatment (MAT) How many patients are you treating on average per month by medication?
