Committee Reports

A. Finance

a. Olga provided the financial report. It has been redesigned by program and grant. Grant periods will be added to the report. This should make it easier to read and understand. "Pass thru" grants will be added in the future as well.

B. Program Reports

a. Reports were provided in the board packet. It was mentioned that CSFP numbers continue to be down. For utility assistance, the spending has been done with the CARES program.

Old Business

- A. Megan Kwantes started at CAA on January 31, 2022. She will be running the food programs. Megan is working on her master's degree in Public Health. She is passionate about food justice.
- B. Walk for Warmth updates: Saturday, February 5, is the date for the Walk. The event is held at City on Hill in Zeeland. The Fillmore Complex and the Health Department building are holding a "Jeans Week" fund raiser. Funds raised so far have reached \$14,000 with \$10,000 of that coming from SEMCO Energy. There is still a need for volunteers at the registration table, food and coffee stations. Let Jen know if you are interested.

New Business

- A. A board training video was played. The video was called "Staying A-board: 5 Ways to engage and retain board members." Jen asked for board members to send her any feedback.
- B. There are volunteer opportunities available to board members. Strategic planning is coming up. Food programs need volunteers on an ongoing basis for packing, distributions and paperwork. Please let Jen know if you are interested in helping.
- C. CRF monitoring is complete. The report was provided in the board packet. There was one finding for the lack of a customer signature in the gift card program.
- D. The weatherization deferral program is starting. This program will cover repairs that are keeping weatherization clients from moving forward. The grant is through DOE and is \$40.000.
- E. Feeding America has taken over our food deliveries for the CSFP program. Most deliveries take place on the second Tuesday of the month. There are just two sites on Thursday. Feeding America may have a grant to cover the cost. This is still to be determined.
