- 2.) The owner or borrower failed to comply with the Administrative Rules promulgated pursuant to Part 91 of the Natural Resources and Environmental Protection Act, Public Act 451 of 1994, as amended by Public Act 504 of 2000.
- 3.) The owner or borrower failed to adhere to the restrictions, limitations and instructions of the Soil Erosion and Sedimentation Control Permit or failed to complete such work by the time stated on the permit.
- 4.) The owner or borrower failed to comply with the County of Ottawa Soil Erosion and Sedimentation Control Ordinance promulgated under the provisions of Part 91 of Public Act 451 of 1994, as amended.

We agree with the drawers, endorsers and bona fide holders of drafts drawn and negotiated in compliance with the terms of this letter of credit that such drafts shall be honored on presentment and delivery of the above specified documents.
