- 2. Human Resources Policy Review Marie Waalkes reported the auditors wanted to see Procedure for the Remembrance and Procedure for Reimbursement of In-County Refreshments, Meals, and/or Snacks put into one policy. - 3. Proposal to Demolish Co-op Extension Building in Grand Haven The Administrator passed out the proposed Grand Haven Maintenance Building and site plan. The Co-op Extension Building will be demolished at the same time as the old Courthouse. Possible construction of the new Maintenance Building will begin next year.
