- 3. Ottawa County Board Prioritization List June Hagan is looking at all budgets and one time dollars. Administration is still looking at making significant cuts in certain programs. If the 4.7 million in revenue sharing is cut, this will become a whole other issue. The Administrator reported he is close to having a report on duplicated human services and what is funded through Ottawa County.
