HHS 11-008 Motion: To approve the agenda of today as presented and amended adding Discussion Item 5A – Health Department Licensing for Restaurants and to approve the minutes of the March 9, 2011, meeting as presented.

#### SUBJECT: DISCUSSION ITEMS

- Services to Senior Citizens Stan Roth, Georgetown Township, is an advocate for senior issues in Kent County and addressed the lack of services available for seniors. He went to the Ottawa County website and couldn't find any links to services available. There is a need to look harder at keeping older citizens in their homes. The southeast portion of the county has the largest population but the least amount of services for the elderly. Kent County has had a millage since 1996.
   Mr. Roth asked the committee if the county would explore this option for Ottawa.
- 2. Update from Senior Resources Pam Curtis, Director of Senior Resources of West Michigan, confirmed Mr. Roth's concerns. Senior Resources has a 500 person waiting list for services today. Homebound seniors are the primary focus and there is no funding for active seniors. Cuts from the state have occurred over the last three years. The state and federal government are not prepared for the senior population. Services are not adequate now and are only going

to get worse. Pam stated Senior Resources is willing to work with the county on a millage.

Mr. Holtrop asked the Administrator to have a link to Senior Resources made available on the county website. Donna Cornwell will contact the United Way to see if they would be willing to address this issue and do an analysis and then report back to this committee.

- 3. County Health Rankings Lisa Stefanovsky reported the Health Department ranked #1 among all the counties in Michigan in the overall health of the citizens. Michigan ranked 30<sup>th</sup> in the U.S.
- 4. Health Department Food Licenses Greg DeJong was questioned why the 2012 invoices have gone out so far in advance. Lisa Stefanovsky stated the licenses are due every year in April. She is going to check on the mandate and get back with Commissioner DeJong.
- 5. Department Updates –

Department of Human Services – Michelle Martin reported on food assistance for college student. Prior to April 1<sup>st</sup>, Ottawa County had 3,176 college student receiving food assistant. On April 1<sup>st</sup>, 2,390 of those cases were closed. 786 college students are still receiving food benefits based on the established criteria.

Community Mental Health – Lynne Doyle reported the CMH accreditation was last week and everything went really well. The Department of Community Health is coming in at the end of this month.

Health Department – Dr. Heidel reported the fastest growing specialty field is gerontology.

Human Services Coordinating Council – Donna Cornwell presented a brief update.

## Why Collect Pharmaceuticals

- Prevent accidental poisoning and ingestion
- Prevent abuse
- Remove from waste stream and environment
- Once in wastewater they can be difficult to remove

# Awtumn Minnema, 2 years old



### Awtumn Minnema

- Ingested her grandfathers anti-psychotic drugs
- Found dead the next day
- Grand Rapids, MI 11/15/2010
- Toxicology Report Shows Toddler Likely Died of Accidental Prescription Drug Overdose...Chicago Tribune.

# What happens when drugs enter the environment

- Endocrine disruption
   Endocrine system regulates growth and maturity of animals
- Male fish exhibiting "feminization"
- Antibiotic resistant bacteria

# **Endocrine Disruption**



## Feminization of Male Fish

- Male Fish Producing Eggs in Potomac River ... National Geographic, 2004
  - First sample 42%, second sample 79% of male fish showed sexual abnormalities.
  - Same article-studied three rivers in the Denver area, all three had reproductive abnormalities downstream from the effluent discharge
- Also seen in England

## What about here

- USGS study 1998-2005, Michigan only
- Sampled statewide
- As expected, large rivers at end of their watershed showed majority of contaminants
- Grand River at Eastmanville- 9 of 10 samples had pharmaceuticals- 2 met/exceeded RL
- Kalamazoo River at New Richmond- 7 of 11 samples had pharmaceuticals- 2 met/exceeded RL

# USGS study...

- Did not test for some of the more common prescriptions
- Also tested for antibiotics and waste-water compounds

## Sales of medication

OTC drug sales have risen 60% since the 1990's

 3.4 Billion prescriptions were written in 2006

3.9 Billion prescriptions were filled in 2009

## Household Medication Disposal Program

- Continuous
- OCHD accepts meds at 3 locations-Holland, Grand Haven, Hudsonville
- Special one day collection events
- Free
- Cannot knowingly accept controlled substances
- Used daily by residents


# Special Pharmaceutical Collection Event

- September 25, 2010
- Must have law enforcement on site
- MUST register with the DEA for <u>every</u> single day event
- Located at Holland OCHD office
- Past collections at Holland and Grand Haven

- Skips Pharmacy-Holland
- Sheriffs Department
- Ottawa Substance Abuse Program (OSAP)
- Volunteers

## Non-Controlled Substances



# Controlled Substances



## Impact

- Three 55 gallon drums of medications
- Approximately 600 pounds of noncontrolled substances sent for incineration
- 25-30 pounds of controlled substances
- Served approximately 230 individuals
- Also accepted veterinary medications
- Pharmacist valued collection at \$100,000

# Going Forward

- Grant from the MDA for pharmaceutical disposal
- Use Kent County Waste to Energy facility
- Expand program to area pharmacies/law enforcement locations
- Outreach to Hospice, nursing homes, home health businesses and dr.'s offices
- Look at alternatives to disposal
