SUBJECT: DISCUSSION ITEMS

- Public Health Legal Authority Citing "Michigan's Guide to Public Health for Local Governing Entities (County Commissioners, Boards of Health and City Councils) – An overview of the role County Commissioners have with Public Health was presented by Lisa Stefanovsky.
- 2. Data and Updates from the Source Tracking/Dog Screening Project at Dunton Park Addie Hambley updated the Committee on this project. After three days of testing in September, the preliminary results are in. She reported this program has received national attention and results are being written for publication in a scientific journal.

3. Department Updates

Human Services – A judge has determined there wasn't enough notice given to implement the time limits on cash assistance. The Department of Human Services is in the process of rewriting the notice and implementation could go back into effect November 1st.

Mental Health – Lynne Doyle reported CMH has been awarded a \$45,000 Block Grant which will be used to hire another Peer Support Specialist. The State is considering doing pilot projects on dual eligibility before going forward with the whole State.

Human Services Coordinating Council – Donna Cornwell reported Senior Resources is gathering information and would like to present it to this Committee. She briefly talked about the Community Navigator Program, Food Policy Counsel, breast cancer screening and the opening of senior housing in Holland.

MI Works!/CAA – Bill Raymond presented updates on the Housing Commission, how to utilize CAA funding resources for long term issues, West Michigan Strategic Allegiance is not going to recommend any major shifts for Workforce Development, audit issues, the Prisoner Re-Entry Program and Second Chance Grant, Michigan Works Steering Team, Peer Michigan Event for college seniors and the CAA Weatherization Program.

Health Department – Lisa Stefanovsky reported on the Healthy Michigan Fund, being awarded a couple of small grants so employees can continue receiving ongoing education, and the Holland City contract for food inspections. This contact expires December 31st. If Holland City doesn't renew, the Health Dept. would have to take it over and ask for an increase in staff.

Dr. Heidel reported two cases of flu have been reported on the eastside of the State. The vaccine being given this year is the same as last year's vaccine. Vaccines only last six to eight months so it's important to receive another flu vaccine this year. The Health Department will not be offering flu clinics this year because there are so many other outlets offering the vaccines.

Summary of Services Gap Meeting for Ottawa County

On September 26th a meeting was held at the Fillmore Complex to discuss the gaps in services available to older adults in Ottawa County. Gaps would include services that are not currently available, services that are available but lack capacity and services that may only be available in certain areas of the County. A variety of service providers were invited to attend. Some provide services specific to older adults and some provide a broad spectrum of services to a variety of ages including older adults. There were approximately twenty in attendance that represented: assisted living homes, nursing homes, senior centers, the Latino community, Department of Human Services, in-home care services, legal services, Love, INC, respite services for caregivers and the senior community.

The first part of the meeting was spent brainstorming the service gaps. All ideas were recorded on large easel pads. The group than completed a modified SWAT analysis where each participant was able to identify what they saw as their top five gaps from the brainstorm list. The top 5 gaps were than identified and the group began addressing why they thought it might be a gap – for example, the program or service is not available, the service is only available in certain areas, the service is available but has inadequate funding, there are program limitations or qualifiers, or the service is not affordable.

Identified Service Gaps

- Helping individuals find natural/community (informal) supports
- Capacity are we behind?
- Bilingual & culturally prepared care providers/services for mono-lingual seniors
- Preparation & preparedness for retirement transitions
- 2nd careers
- Policy making
- Case Manager for everyone *
- Fitness programs targeted towards older adults & fitness programs to help manage chronic disease
- Nutrition Education
- General education of the aging process
- Assistance with paperwork Veterans, Medicaid, Medicare
- Dental Services
- Physicians that accept Medicaid/Medicare
- MIChoice Home & Community Based Services waiting list
- Nutrition/food for people in their homes
- Oversight of licensed/unlicensed staff in living facilities
- Caregiver support
 - o Including affordable respite care
- Supports Coordination "one stop shop"
- Affordable housing
 - Waitlists at risk housing
- Home repairs
- Food assistance
- Collaboration between service providers of all ages
- Home health services for seniors with limited financial services/affordable
- Medication costs/assistance
- Home modifications for accessibility affordable

- Resources to investigate elder abuse

Top 5 Needs Identified by the Gaps Identification Group (in no particular order):

- 1. Supports Coordination
- 2. Assistance with paper work group consensus was to combine these 2 gaps
- 3. Transportation
- 4. Mental Health Services
- 5. MiChoice Waiver

Supports Coordination – it was the consensus of the group to combine supports coordination and assistance with paperwork into one identified gap. It was felt that assistance with paperwork would be provided through a supports coordinator. The group felt the following components were important:

- coordination across all services would be more seamless/someone to cut through the chase/no wrong door
- the development of an Aging and Disability Resource Collaborative in partnership with 2-1-1
- community awareness people need to know who to call
- supports coordination that takes into consideration not just the preferences of the whole person but their family and supports system as well

Transportation –

- Only available in certain areas
- Difficult for disabled or frail consumers as they don't often know when an appointment will end for scheduling.
- In the townships that receive senior millage dollars no one has been denied volunteer transportation
- Those needing specialized transportation (handicap accessible) are unable to access volunteer transportation
- The types of non-public available transportation vary by service provider. Example: medical only, jobs only, or shopping
- Limited or no night service county wide
- In ability to access transportation outside county lines

Mental Health Services -

- Lack of affordable mental health services
- Community Mental Health system is currently taxed
- Not enough specialists in senior related issues in the mental health system
- There is a need for mental health services within long term care facilities
- Lack of an official diagnosis makes it difficult for senior consumers to initiate/access community services (hording, depression, dementia)
- Issues related to drug/medication interactions

Home and Community Based MiChoice Medicaid Waiver Program -

- Current waiting list is over one year for a cost efficient alternative to nursing home placement
- Current waiting list needs to be continually cleaned up as people's needs or situations change
- Need for continued advocacy for more service dollars

Supports Coordinator Response

A separate opportunity to provide input was offered to the supports coordinators (case managers) from Senior Resources, Evergreen Commons and the North Ottawa County Council on Aging. These are the people out in the community in client homes. Their perspective takes into consideration what they have experienced with their clients who have the inability to pay for services privately.

- Waiting lists for in-home services for those clients needing assistance through federal and state funds (homemaking, medication management, assistance with bathing, in-home respite and adult day care)
- Transportation especially outside Holland, the Tri-Cities and Georgetown Township
- Medical Transportation (County wide)- especially if someone needs to see a specialist in GR or outside the area.
- Chore Services snow removal, lawn care, grab bar installations
- Utility bill assistance
- Hearing Aid assistance
- Conservators
- Access to food pantries for the homebound
- Dental services (affordable or accept Medicaid)
- Medicare Medicaid Assistance Program (MMAP) Services—Georgetown/Hudsonville area
- Friendly Visitor/Telephone Reassurance
