HHS 12-016 Motion: To approve the agenda of today as presented and to approve the minutes from the August 8, 2012, meeting as presented.

SUBJECT: DISCUSSION ITEMS

1. Proposed New Fee for Food Service Sanitation Program: "Cook Off" Fees – Spencer Ballard, Food Service Team Supervisor, explained the proposed new fee which will reduce the cost of obtaining a license for a Cook Off.

The current cost with 10 participants: Standard - \$158 each = \$1,580
Non-Profit - \$55 each = \$550

Proposed cost for 10 participants: Standard - \$158 + 10 @ \$50 = \$658
Non-Profit - \$55 + 10 @ \$25 = \$305

HHS 12-017 Motion: To approve and forward to the Board of Commissioners the proposed New Fee for Food Service Sanitation Program reducing the cost of obtaining a license for a Cook Off to the current fee for a single Temporary License (\$158) plus \$50 per license or \$25 per license when non-profit.

Spencer also spoke on the new Food Code for the State of Michigan which will go into effect on October 1st. Environmental Health employees will be going to training next week. They will then put together a training program and invite local restaurants.

2. Ottawa County Food Policy Council Strategic Plan – A powerpoint presentation on the Ottawa County Food Policy Council Strategic Plan was presented by Lisa Uganski, Nutritionist and Health Educator.

3. Department Reports:

Dept. of Human Services – Michelle Martin reported on a conference she attended which talked about hearing and visual disabilities and getting barriers removed.

Health Department – Dr. Heidel reported on the West Nile Virus. There have been 137 cases in Michigan with 29 in Kent County and 1 in Ottawa County.

Lisa Stefanovsky reported the Executive Committee of the Coordinating Council has been interviewing for the Human Services Coordinating Council Director position. Lisa will be sending out the “Miles of Smiles” schedule to the Commissioners. She also reported James Haveman is the new State Health Director. The Health Department has been told to expect changes and integration of services.
