SUBJECT: DISCUSSION ITEMS

1. Ottawa Food-Lisa Uganski gave a brief overview of what Ottawa Food is. Their priorities for Ottawa County are: 1. Reduce hunger and food insecurity, 2. Encourage healthy eating, and 3. Increase sourcing of local foods. She then talked about the things that they have been working on throughout 2020. One thing is that they have partnered with a local marketing firm to encourage people to eat more fruits and vegetables. She then shared some food insecurity data back to 2011. And finally, she said they have done a lot of work with food pantries and farmers this year and talked about a new program that they developed that partners with 7 local farmers to get their food into local food pantries. This ran from July to late October. She also mentioned that she is working with Emergency Management and some other organizations to create an Emergency Food Response plan for Ottawa County.
2. Department Updates
 - a. Public Health Department- Lisa Stefanovsky didn't have any new updates from when she spoke yesterday at the Board meeting.

- b. Human Services Coordinating Council- Patrick Cisler updated that the Human Services Response Team has been meeting more frequently again. They are looking at a variety of different issues that are affecting Ottawa County right now. Their top priority currently is how to keep kids in school.
- c. Community Mental Health-Lynne Doyle updated that they are still mostly using telehealth to help their consumers. They are now being reimbursed for these services. They have been spending a lot of time right now getting their two new grants up and running. She also commented that funding looks like it is heading in the right direction.
- d. Department of Human Services – Kendra Spanjer said that they continue to be closed to the public in their lobby until at least March 2nd, 2021. They still have all services in place despite the closure. She then shared some data on CPS cases and assistance cases from 2019 compared to 2020.
