WHEREAS, the Ottawa County Board of Cor Committee on September 24, 2024, to facilitate the and	
WHEREAS, the County of Ottawa is currently w	ithout a County Administrator, and
WHEREAS, the County Administrator serves as	the Chief Administrative Officer of the County

WHEREAS, the County Administrator acts as a coordinator and performs executive management level leadership in directing the overall management of the County government to provide mandated services to the citizens of Ottawa County, and

of Ottawa and is responsible for the management of all County operations, programs, and

WHEREAS, the County Administrator upholds the United States and Michigan Constitutions to preserve and protect the individual rights of the citizens, and

WHEREAS, the County of Ottawa has essential operations to continue under the direction of an Interim County Administrator, and

WHEREAS, the current Deputy County Administrator is Benjamin Wetmore, and

WHEREAS, Benjamin Wetmore is willing to serve as Interim County Administrator while the search for a permanent County Administrator is conducted, and

WHEREAS, the salary range of the County Administrator is \$185,000 to \$220,000 per year;

NOW, THEREFORE BE IT RESOLVED, Benjamin Wetmore is appointed as Interim County Administrator, to continue until the employment of a permanent replacement or further action by the Board of Commissioners, and

BE IT FURTHER RESOLVED, Benjamin Wetmore shall be paid at the rate of \$175,000 per year while appointed as the Interim County Administrator, and

BE IT FURTHER RESOLVED, Benjamin Wetmore shall return to the position and pay of Deputy County Administrator after a permanent County Administrator is appointed, and

BE IT FURTHER RESOLVED, the Interim County Administrator position is a full-time, benefited position working at the Fillmore Complex in West Olive, Michigan, and

BE IT FURTHER RESOLVED, the Interim County Administrator shall be responsible for all day-to-day administration of the County of Ottawa, and

BE IT FURTHER RESOLVED, the Interim County Administrator shall direct the operations and supervise the performance of all County departments and department heads, and is the final authority for decisions related to employee behavior, discipline, selection, appointment, removal, and policy enforcement, however, this authority shall not apply to elected officials or officials that have been appointed by the Board of Commissioners, and

BE IT FURTHER RESOLVED, the Interim County Administrator shall attend and/or have department heads attend all Board of Commissioners meetings and supervise the preparations and filling, or submission, of all reports required of the County by law, and

BE IT FURTHER RESOLVED, the Interim County Administrator serves as an official representative on a variety of boards and with the public, and

BE IT FURTHER RESOLVED, the Interim County Administrator shall assist the Executive Transition Committee with the search for a permanent County Administrator, and

BE IT FURTHER RESOLVED, the Interim County Administrator shall perform such other duties as is customary or the Board may assign.
