We have completed review of the proposed plat and note the following reasons for rejection

- 1. Please provide a recorded discharge of the two mortgages listed in the title policy, or add the two mortgagees to the plat as proprietors, as/if applicable, [MCL 560 144]
  - Have the county plat board re-approve after addition of the mortgagee proprietors, if applicable; [MCL 560.168]
- 2. Add the approval date to the Municipal Certificate; [R 560 121]
- 3. Please provide the following items:
  - a A recorded release of the recorded highway maintenance easement; [R 560 112]
  - b. The water and sewer permits, [R 560 121]
  - c. A complete copy of the recorded pond easement, including the attached Exhibits A-C, [R 560.112]
  - d. A recorded copy of the 2009 B-6 remonumentation LCRC;
  - e. Written confirmation from the township acknowledging the approval date added to the Municipal Certificate and a copy of the township's final plat approval meeting minutes,

## f Revised restrictions that address

- 1. Have the two *mortgagees* that are listed in the title policy sign the restrictions, if applicable,
- ii Revise the acknowledgement to include the *corporation name* and *state*, as applicable, [MCL 565.267]

Have the revised restrictions resigned by all proprietors after the necessary revisions We are returning the original restrictions (and the recording fees) enclosed.

- 4. Please address the following drafting revisions:
  - a Add the interior dimensions and ¼ line tie dimensions; [R 560 112]
  - b. Add the corporation file date, [R 560.106]
  - c. Add most recent LCRC recording data to corner B-6; [R 560.112]
  - d Address the other minor drafting items noted on enclosed plat mark-up copy.

Please feel free to contact our office for clarification of the above issues, if necessary

The revisions are based on the Land Division Act 1967 PA 288, MCL 560.101 et seq and the administrative rules (2008 MR10, R560.101-135)

If any governmental reviewing agency believes that any of the above requested revisions to the proposed plat drawing would alter their conditions of approval for this subdivision, please contact the Office of Land Survey and Remonumentation (OLSR). If the OLSR is not contacted by any governmental reviewing agency which expresses their concerns in regard to the revisions requested by the OLSR, OLSR will continue to process this subdivision for recording.

Please be aware that plat records will be held for two years after the date of our last rejection letter. A plat that is resubmitted after the two years will be treated as a new file, and all required documentation must then be resubmitted with the plat
