- Bill Smith reported that Dale Vredeveld, current Undersheriff at the Ottawa Co. Sheriff's Dept. would be retiring on January 30, 2004. Sheriff Gary Rosema announced recently that Lt. Greg Steigenga from the Ottawa Co. Sheriff's Dept. will be promoted to the position of Undersheriff.
- Elections for a new Chairperson, Vice Chairperson, PIO and Emergency Management Director were held. There was a motion from the floor that Myra Reimink be nominated as the Chairperson. Chief Dan Henderson moved that the nominations be closed and a unanimous ballot cast for Myra Reimink. Bonnie Schuitema seconded the motion and the motion passed.
