## HAZMAT/TECH RESCUE TEAM UPDATE

- 12-12-05 three members responded to the Nunica Bar where some males in the bathroom lit a substance in an ashtray resulting in white smoke with an odd smell. Sample bags of the powder were collected and given to the Sheriff's department.
- 12-21-05 there was a tanker spill on M-104 in Spring Lake when a car made a u-turn in front

of a tanker carrying gasoline and diesel, causing it to swerve and roll onto its side. Crockery Fire and HAZMAT responded. It is estimated that 2,500 of the 8,000 gallons of fuel were spilled. The mobile command unit was utilized with great results. Some homes were evacuated. There were no injuries.

• The HAZMAT team would like to move all three of their trucks into one garage.
