The Grand Oak Subdivision No. 3 Drain will be let in one section as follows, having the length, average depth and width as set forth:

A mandatory pre-bid conference for the contract will be held on Tuesday, May 21, 2024 at 10:00 a.m. at the project job site located at the intersection of Oak Chapel Avenue and Forest Park Drive in Grand Haven, Michigan 49417.

A security deposit in the form of a cashier's check, money order, certified check or bidders bond shall be submitted with any bids. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the

Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.
