The Ottawa County Water Resources Commissioner will meet on the above date, time and location to receive construction bids for the Eagle Ridge Estates Drain. Bids will then be opened and publicly announced.

The Eagle Ridge Estates Drain will be bid in section(s), each section having the length, average depth and width as set forth in the bid documents; briefly described as follows:

Work shown on the drawings and specified herein generally described as: 1,733 lineal feet of open drain construction, cleanout and two-stage channel including: selective clearing, excavation, spoils management and grading, bank shaping, rip rap, restoration and 117-inch by 79-inch culvert installation. The restoration of 3 ponds and detention basins with outlet control structures including gabion baskets, cobblestone channels and sediment forebay. 1675 lineal feet of 6-inch to 24-inch enclosed storm sewer with associated appurtenances including end sections, headwalls, drainage structures, 6" service leads and infiltration swales; and also including HMA roadway restoration and gravel shoulders.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.

The Water Resources Commissioner and/or other staff will be available to assist individuals throughout the day, and make revisions if necessary. There is no need to schedule an appointment for a specific time on the Day of Review. The computation of costs for the Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected by installment, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Water Resources Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

You may appeal the Water Resources Commissioner's decision to revise the district boundary to the Ottawa County Circuit Court, and you may also appeal the determination of apportionments to the Ottawa County Probate Court within ten (10) days of the Day of Review.
