PETITION FOR LOCATING, ESTABLISHING AND CONSTRUCTING A DRAIN

BIRCHWOOD DRAIN

To the Ottawa County Water Resources Commissioner:

The signers of this petition request that the Birchwood Drain be located, established and constructed under the provisions of Chapter 4 of Public Act 40 of 1956, as amended, to alleviate drainage issues in the Drainage District.

The tentative location of the proposed Birchwood Drain is as described in the Order Laying Out and Designating the Birchwood Drain Drainage District, dated January 21, 2022.

This petition is signed by a number of freeholders with lands liable for assessment in the Birchwood Drain Drainage District, equal to at least half the number of freeholders whose lands would be traversed by the proposed drain.
