
The proposed drain is located in Spring Lake Township, Ottawa County, Michigan.


The proposed drain is necessary for the public health, convenience or welfare and is further necessary for the protection of the public health of Spring Lake Township.



The proposed drainage district that will pay for the costs of the proposed drain is located in Spring Lake Township, Ottawa County, Michigan.


The proposed drain is necessary for the public health, convenience or welfare and is further necessary for the protection of the public health of Spring Lake Township.

Spring Lake Township understands that it will be liable for an assessment at large against it for a percentage of the cost of the proposed Bridlepath Drain.


The tentative location of the proposed Bridlepath Drain is as follows:
