The Ottawa County Water Resources Commissioner will meet on the above date, time and location to receive construction bids for the Cooper Drain. Bids will then be opened and publicly announced.

The Cooper Drain project will be let in 1 section(s) as follows, each section having the length, average depth and width as set forth:

Approximately 3,630 lin. ft. of open channel cleanout with an average ditch depth of 4 feet. Approximately 1,500 lin. ft. of selective clearing, grubbing, and snagging. The project also includes installation of plain riprap, road and driveway restoration, seeding, as well as the installation of the crossings listed below.

Bids will be made and received in accordance with these documents. Bidding Documents, including plans and specifications, may be examined at the Ottawa County Water Resources Commissioner's Office.

A **mandatory** pre-bid conference will be held at 10:00 a.m. local time on Tuesday, January 23, 2024 at the Ottawa County Water Resources Commissioner's Office (12220 Fillmore Street, Room 141, West Olive, MI 49460).

Copies of Bidding Documents may only be obtained at the mandatory pre-bid conference.

A security deposit in the amount 5% of the total bid shall be submitted in the form of a cashier's check, money order, certified check or bidders bond with any bid. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.
