**CORPORATE GROVE DRAIN**

**WHEREAS**, an application, dated October 11, 2016, has been made and filed with me, the Ottawa County Water Resources Commissioner, for the Laying Out and Designating of a Drainage District; and

**WHEREAS**, the County Treasurer has provided a statement that less than 33 1/3% of the lands in the proposed drainage district owe taxes and special assessments over the preceding three years; and

**WHEREAS**, I retained *Spicer Group* to perform a survey of the proposed drain and drainage district.


**NOW, THEREFORE**, I do hereby determine:

1. The name of the drain is the Corporate Grove Drain.
2. The Drainage District boundaries are as described in the attached *Exhibit A*.

**ROUTE & COURSE DESCRIPTION**

Section 4, T.5 N.-R.13 W., City of Hudsonville  
Ottawa County, Michigan

The Route and Course of the Corporate Grove Drain is as follows:

Commencing for outlet at a point in the Southwest 1/4 of Section 4, which is S.88°-42'-34"E., on the East and West 1/4 line of said Section, 2155.71 feet and 506.08 feet, S.00°-00'-00"W., of the West 1/4 corner of Section 4, T.5 N.-R.13 W., City of Hudsonville, Ottawa County, Michigan; thence N.28°-27'-46"W., 653.98 feet to Reference Point "A"; thence S.61°-13'-17"W., 255.68 feet; thence S.36°-52'-12"E., 34.72 feet and there end. The total length of said route and course being 944.38 feet.

ALSO

Commencing at Reference Point "A"; thence N.80°-34'-39"E., 56.59 feet and there end. The total length of said route and course being 56.59 feet.
