The Ottawa County Water Resources Commissioner will meet on the above date, time and location to receive construction bids for the Cory Bishop Drain. Bids will then be opened and publicly announced.

The Cory Bishop Drain will be let in two Contracts as follows:

Contract No. 1: Work shown on the drawings and specified herein generally described as: lake bottom dredging of Georgetown Shores Lake at the stream outlet of the Cory Bishop Drain and consisting of 1,750 cubic yards of lake dredging and associated spoil drying, removal and lawn restoration.

Contract No. 2: Work shown on the drawings and specified herein generally described as: 3,500 lineal feet of open drain construction, cleanout and two-stage channel including: selective clearing, excavation, spoils management and grading, coir logs, toe wood, bank shaping, slope stabilization, rip rap, and lawn restoration. The construction of three gabion mattress and gabion basket outfall structures

This Notice of Letting, the plans, specifications and bid proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents now on file at the Office of the Ottawa County Water Resources Commissioner and available to interested parties. A 5% security deposit in the form of a bank money order, certified check or bidders bond shall be submitted with any bids, made out to the "Cory Bishop Drain Drainage District." No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contracts are awarded.

The Contracts will be awarded to the lowest responsive and responsible bidders giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion dates and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.

The Ottawa County Water Resources Commissioner will hold a Day of Review of Apportionments and Drainage District Boundaries on the above date, time and location.

The Day of Review is an opportunity to review the tentative apportionment of benefit for each parcel and municipality within the Drainage District and to review the description of lands comprising the Cory Bishop Drain. A map of the proposed Drainage District Boundary is enclosed and can be found on the Ottawa County Water Resources Commissioner's website at:

The Water Resources Commissioner and/or other staff members will be available to assist individuals throughout the day, and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. The computation of costs for the Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected by installment, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Water Resources Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

You may appeal the Water Resources Commissioner's decision to revise the district boundary to the Ottawa County Circuit Court, and you may also appeal the determination of apportionments to the

Ottawa County Probate Court within ten (10) days of the Day of Review.
