Use the Bid Form in the specifications for submittal of sealed bids. **You must download the Contract Documents from Quest CDN to bid on the project, to be included on the planholders list, and to receive Addenda.** The Contractor is responsible for ensuring all addendums have been received and acknowledged prior to submittal of the bid.

A **mandatory** pre-bid conference will be held at 10:00 a.m. local time on Tuesday, March 1, 2022 at the Ottawa County Water Resources Commissioner's Office (12220 Fillmore Street, Room 141, West Olive, MI 49460).

A security deposit in the amount 5% of the total bid shall be submitted in the form of a cashier's check, money order, certified check or bidders bond with any bid. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.
