**RESOLUTION FOR APPLICATION FOR LAYING OUT AND DESIGNATING A DRAINAGE
DISTRICT AND PETITION TO LOCATE, ESTABLISH AND CONSTRUCT A DRAIN
HUDSON TRAILS DRAIN**

Commissioner Leerar, supported by Commissioner Brandsen, moved the adoption of the following resolution:

WHEREAS, the City requests the laying out and designating of a county drain drainage district, located in Ottawa County, pursuant to Chapter 3 of Public Act 40 of 1956, as amended; and

WHEREAS, the City requests the location, establishment and construction of a drain, located in Ottawa County, pursuant to Chapter 4 of Public Act 40 of 1956, as amended; and

WHEREAS, the City has determined that the laying out and designating of the proposed drainage district and the location, establishment and construction of the proposed drain are necessary for the public health in the City; and

WHEREAS, the City will be liable for an assessment at large against it for a percentage of the cost of the proposed drain.

NOW, THEREFORE BE IT RESOLVED THAT, the City Commission does authorize the filing of an application with the Ottawa County Water Resources Commissioner for the laying out and designating of a drainage district.

BE IT FURTHER RESOLVED THAT, the City Commission does authorize the filing of a petition with the Ottawa County Water Resources Commissioner for the location, establishment and construction of a drain.

BE IT FURTHER RESOLVED THAT, the Mayor is authorized to execute the application for the laying out and designating of a drainage district and the petition for the location, establishment and construction of a drain.

BE IT FURTHER RESOLVED THAT, the Clerk shall forward to the Ottawa County Water Resources Commissioner a copy of this Resolution for the application for laying out and designating a drainage district and the petition for the location, establishment and construction of a drain.




The proposed drain is located in the City of Hudsonville, Ottawa County, Michigan.
