PLEASE TAKE NOTICE that pursuant to Chapter 20 of Act 40, Public Acts of Michigan 1956, a petition was filed with the Ottawa County Water Resources Commissioner by Holland Charter Township, Ottawa County, Michigan, requesting said Water Resources Commissioner to locate, establish, and construct the James Street-Westshore Drain, for purposes of facilitating a public improvement consisting generally of:

Establishment of drainage facilities (including storm sewers, manholes, catch basins, and catch basin leads and excluding underdrain, sump lines, and private storm connections) under the authority of the Ottawa County Water Resources Commissioner.

PLEASE TAKE FURTHER NOTICE that the Drainage Board for the James Street-Westshore Drain has considered said petition and made a tentative determination that the petition is sufficient and that project is practicable. The Drainage Board has further determined to continue the name "James Street-Westshore" as the name of the drain, and has made a tentative determination that the following public corporations should be assessed for the cost of the project as follows:

OTTAWA COUNTY, Michigan for benefits to the public health.

HOLLAND CHARTER TOWNSHIP, Ottawa County, Michigan for benefits to the public health.

MICHIGAN DEPARTMENT OF TRANSPORTATION, for benefits to public health.

PLEASE TAKE FURTHER NOTICE that the Drainage Board will meet at the above date, time and location for the purpose of hearing any objections to the proposed drain and the petition for the drain, and to the matter of assessing cost of the drain to the designated public corporations named above.

Proceedings conducted at this public meeting will be subject to the provisions of the Michigan Open Meetings Act. Information regarding this Meeting may be obtain from the Ottawa County Water Resources Commissioner's Office at the above-listed contact information.
