A DRAINAGE DISTRICT**

**LILAC DRAIN**

**WHEREAS**, an application, dated January 22, 2024, has been made and filed with me, the Ottawa County Water Resources Commissioner, for the Laying Out and Designating of a Drainage District; and

**WHEREAS**, the County Treasurer has provided a statement that less than 33 1/3% of the lands in the proposed drainage district owe taxes and special assessments over the preceding three years; and

**WHEREAS**, I retained *Spicer Group, Inc.* to perform a survey of the proposed drain and drainage district.


**NOW, THEREFORE**, I do hereby determine:
