WHEREAS, the City of Ferrysburg requests the laying out and designating of a county drain drainage district, located in Ottawa County, pursuant to Chapter 3 of Public Act 40 of 1956, as amended; and

WHEREAS, the City of Ferrysburg requests the location, establishment and construction of a drain, located in Ottawa County, pursuant to Chapter 4 of Public Act 40 of 1956, as amended; and

WHEREAS, the City of Ferrysburg has determined that the laying out and designating of the proposed drainage district and the location, establishment and construction of the proposed drain are necessary for the public health in the City of Ferrysburg; and

WHEREAS, the City of Ferrysburg will be liable for an assessment at large against it for a percentage of the cost of the proposed drain.

NOW, THEREFORE BE IT RESOLVED THAT, the City Council does authorize the filing of an application with the Ottawa County Water Resources Commissioner for the laying out and designating of a drainage district.

BE IT FURTHER RESOLVED THAT, the City Council does authorize the filing of a petition with the Ottawa County Water Resources Commissioner for the location, establishment and construction of a drain.

BE IT FURTHER RESOLVED THAT, the City Manager is authorized to execute the application for the laying out and designating of a drainage district and the petition for the location, establishment and construction of a drain.

BE IT FURTHER RESOLVED THAT, the City Clerk shall forward to the Ottawa County Water Resources Commissioner a copy of this Resolution for the application for laying out and designating a drainage district and the petition for the location, establishment and construction of a drain.

To the Ottawa County Water Resources Commissioner:




The proposed drain is necessary for the public health, convenience or welfare and is further necessary for the protection of the public health of City of Ferrysburg.


The proposed drain is located in City of Ferrysburg, Ottawa County, Michigan.


The proposed drain is necessary for the public health, convenience or welfare and is further necessary for the protection of the public health in City of Ferrysburg.
