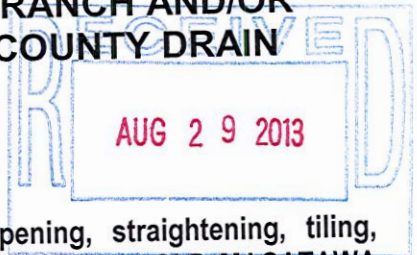


**PETITION FOR CLEANING OUT, RELOCATING, WIDENING, DEEPENING,
