To the Ottawa County Water Resources Commissioner:



This petition has been duly authorized by the governing body of Holland Charter Township and requests that the Perry Ridge No. 3 Drain and Perry Ridge No. 4 Drain be consolidated, maintained and improved as provided in Chapter 8, Act No. 40 of the Public Acts of 1956, as amended.

The Perry Ridge No. 3 Drain and Perry Ridge No. 4 Drain are located in Holland Charter Township, Ottawa County, Michigan.

The proposed consolidation of the Perry Ridge No. 3 Drain and Perry Ridge No. 4 Drain, including adding branches and adding lands to the drainage district and any required maintenance and improvement, is necessary for the public health, convenience or welfare and is further necessary for the protection of the public health of Holland Charter Township.

Holland Charter Township understands that it will be liable for an assessment at large against it for a percentage of the cost of the proposed consolidation, maintenance and improvement.

WHEREAS, the Perry Ridge No. 3 Drain and Perry Ridge No. 4 Drain are county drains located in Ottawa County, established pursuant to the Michigan Drain Code, Public Act 40 of 1956, as amended; and

WHEREAS, Holland Charter Township has determined that the consolidation, maintenance and improvement of the drain is necessary for the public health of Holland Charter Township; and

WHEREAS, Holland Charter Township recognizes that it will be liable for an assessment at large against it for a percentage of the cost of the proposed consolidation, maintenance and improvement.

NOW, THEREFORE BE IT RESOLVED THAT, the Holland Charter Township Board of Trustees does authorize the filing of a petition for consolidation, maintenance and improvement of the drain as provided in Chapter 8, Act No. 40 of the Public Acts of 1956, as amended.

BE IT FURTHER RESOLVED THAT the Supervisor is authorized to execute the petition for consolidation, maintenance and improvement of the drain.

BE IT FURTHER RESOLVED that the Clerk shall forward to the Ottawa County Water Resources Commissioner a copy of this Resolution for the petition for consolidation for the Perry Ridge No. 3 Drain and Perry Ridge No. 4 Drain, including adding branches and adding lands to the drainage district and maintenance and improvement of the drain.
