The proposed drain is located in Spring Lake Township, Ottawa County, Michigan.


The proposed drain is necessary for the public health, convenience or welfare and benefits the public health in Spring Lake Township.

**WHEREAS**, the Township will be liable for an assessment at large against it for a percentage of the cost of the proposed drain.




