The signers of this petition request that the Terrace Drain be located, established and constructed under the provisions of Chapter 4 of Public Act 40 of 1956, as amended, to alleviate drainage issues in the Drainage District.

The tentative location of the proposed Terrace Drain is as described in the Order Laying Out and Designating the Terrace Drain Drainage District, dated September 4, 2020.

This petition is signed by a number of freeholders with lands liable for assessment in the Terrace Drain Drainage District, equal to at least half the number of freeholders whose lands would be traversed by the proposed drain.
