To the Ottawa County Water Resources Commissioner:




The Yonker Drain is located in Spring Lake Township, Ottawa County, Michigan.

**WHEREAS**, the Township will be liable for an assessment at large against if for a percentage of the cost of the proposed maintenance and improvement.


**NOW, THEREFOR BE IT RESOLVED THAT**, the Township Board does authorize the filing of a petition for maintenance and improvement of the drain.


