
The proposed drain is located in City of Ferrysburg, Ottawa County, Michigan.


The proposed drain is necessary for the public health, convenience or welfare and is further necessary for the protection of the public health in City of Ferrysburg.

Commencing at a point approximately 2,083 feet South and 2,331 feet West of the NE corner of Section 17 of the City of Ferrysburg. Thence proceeding approximately 800 feet in a Northerly direction, thence approximately 1,100 feet in a Northwesterly direction to the point of ending, a point being approximately 802 feet South and 2,571 feet West of the NE corner of Section 17 of the City of Ferrysburg.

**WHEREAS**, the City of Ferrysburg requests the laying out and designating of a county drain drainage district, located in Ottawa County, pursuant to Chapter 3 of Public Act 40 of 1956, as amended; and

**WHEREAS**, the City of Ferrysburg requests the location, establishment and construction of a drain, located in Ottawa County, pursuant to Chapter 4 of Public Act 40 of 1956, as amended; and

**WHEREAS**, the City of Ferrysburg has determined that the laying out and designating of the proposed drainage district and the location, establishment and construction of the proposed drain are necessary for the public health in the City of Ferrysburg; and

**WHEREAS**, the City of Ferrysburg will be liable for an assessment at large against it for a percentage of the cost of the proposed drain.

**NOW, THEREFORE BE IT RESOLVED THAT**, the City Council does authorize the filing of an application with the Ottawa County Water Resources Commissioner for the laying out and designating of a drainage district.


